**REQUESTED ACTION:**

Approve the spending authority for the above Agreement. Contract Term: June 12, 2019 through June 30, 2021, 2 Years; User Department: Atlantic Technical College; Award Amount: \$70,000; Awarded Vendor(s): The Housing Authority with the City of Fort Lauderdale; Small/ Minority/Women Business Enterprise Vendor(s): None.

**SUMMARY EXPLANATION AND BACKGROUND:**

The School Board of Broward County, Florida, has partnered with the Housing Authority of the City of Fort Lauderdale for more than twenty (20) years. This Agreement helps to provide the Housing Authority residents with training that can help improve their residential properties and develop employment skills. This program is part of the School Board's Apprenticeship programs that are offered through Atlantic Technical College. This agenda item is to approve the spending authority requested in order to pay the Housing Authority of the City of Fort Lauderdale for the cost of the related classroom instructor.
