Florida Statute 1006.40(5) requires the following steps in approving recommended instructional materials for use district-wide.

- Public online access to student editions of the District recommended instructional materials.
- An open and noticed Public Hearing.
- An open and noticed board meeting to approve an annual instructional materials plan.



Instructional Materials Adoption Process

- 1. Use a review tool that prioritizes content and standardsalignment.
- 2. Provide a rigorous and transparent reviewer selection process.
- 3. Train reviewers to have a top-of-the-class grasp of the instructional shifts and how to apply the tool to materials.
- 4. Inform stakeholders about our process and the rationale behind our decisions.
- 5. Manage publishers to emphasize the District's commitment to high quality content, standards alignment, and meeting IT technical requirements.
