Funds Requested	\$896,751 (requested)
Financial Impact Statement	The potential positive financial impact is \$896,751. The source of funds is the U.S. Department of Health and Human Services. These funds will cover 80 percent of the Head Start/Early Head Start program's cost. An amount of \$324,831 is allocated for Cost of Living Adjustment at a rate of no less than 2%. An amount of \$571,920 is allocated for a Quality Improvement Grant that will be divided to provide the following: supplements for education and education support staff, the addition of two Behavior Specialists and two Inclusion Specialists to support children who exhibit behaviors in the classroom due to trauma in the home and/or disabilities. A professional development plan and support plan on Trauma Informed Care will
	accompany the plan. Quality Improvement funds are allocated proportionately based on federal funded enrollment and will continue every year.  Receipt of the \$896,751 is contingent upon the District providing a required 20 percent in-kind totaling approximately \$223,187. The exact amount of in-kind may vary based upon volunteer hours, donations, depreciation of classrooms and in-kind donation of school staff time spent with Head Start. The Head Start/Early Intervention Department will coordinate with Capital Assets to obtain the information and will calculate the hours spent working with Head Start children by Broward County Public Schools staff not paid with federal funds and provide it to the Head Start Office.

The COLA total award amount is included in the budget justification narrative. The Quality Improvement funds will be used for supplements for education and education support personnel and for additional staff and training to support children exhibiting behaviors in the classroom due to trauma in the home and/or disabilities partnered with professional development in Trauma Informed Care. The HS/EHS Program provides services to 2,120 children and their families.
Evaluation Plan	Performance measures for the HS/EHS program include, but are not limited to, the percentage of HS/EHS students mastering age appropriate skills, depending on the individual benchmarks. <i>Teaching Strategies GOLD (TSG)</i> is the selected online tool used to monitor students' ongoing progress and individualize instruction.
