ARTICLE 17 TERM OF AGREEMENT

- A. This Agreement shall be effective from July 1, 2017, through June 30, 2020, at which time it shall expire. No later than May 1, 2020, either party, by written notice to the other, many commence negotiations for a successor agreement.
- B. For the 2019-2020 school year, the parties agree to reopen base salary and insurance. In addition, each party may select up to two (2) additional issues to reopen. No later than May 1, for each contract year, by written notice to the other, either party may commence negotiations for the reopeners for the 2019-2020 school year.
- C. This Agreement shall be renewed automatically from year to year thereafter unless either party has given written notice of its desire to negotiate revisions in the terms and conditions of the contract.
