FINANCIAL IMPACT: The financial impact of approving this Second GMP Amendment is \$19,996,611. This project has been appropriated in the Adopted District Educational Facilities Plan (September 4, 2019). There is an additional impact to the project budget. These funds in the amount of \$10,706,440 will come from the Capital Projects Unallocated Reserve. This increases the project budget from \$14,426,000 to \$25,132,440.
