**REQUESTED ACTION:**  
Receive RSM Report - SMART Bond Program Management.

**SUMMARY EXPLANATION AND BACKGROUND:**  
The Office of the Chief Auditor (OCA) engages RSM to perform testing of the SMART Bond owner representative (OR) and program manager (PM). The report for the Q2 – 2020 period noted 7 findings. Follow-up on prior findings noted that, 1 of 2 remaining findings from prior reports were closed. The also OCA requested that RSM review the Construction Services Minor Program (CSMP) and documents related to an upcoming Request For Qualification (RFQ) for the OR and PM. Management is addressing comments on both reviews. See Supporting Docs for continuation of Summary Explanation and Background. The Audit Committee reviewed and approved the report and the accompanying documents for transmittal to the School Board during their March 12, 2020 meeting.
