State of Florida Statewide Voluntary Prekindergarten Provider Agreement between the Early Learning Coalition of Broward County, Inc. (ELC) and The School Board of Broward County Florida (SBBC)

REQUESTED ACTION:

Approve the State of Florida Statewide Voluntary Prekindergarten Provider Agreement between the Early Learning Coalition of Broward County, Inc. (ELC) and The School Board of Broward County, Florida (SBBC) to implement the 2020-2021 Voluntary Prekindergarten (VPK) Education Program and to authorize the Superintendent of Schools or his designee to provide any electronic signatures necessary to execute the Provider Agreement.

SUMMARY EXPLANATION AND BACKGROUND:

SBBC agrees to implement the Voluntary Prekindergarten Program (VPK) for school year 2020-2021 and summer 2021. The term of this Agreement will be August 19, 2020 through August 18, 2021. SBBC will provide full-day (6 hours) and half-day (3 hours) VPK instructional models. Program models include: VPK/Extended Day (3-hours); VPK/Enrichment (6 hours that combines 3 hours of free VPK with option 3 fee-based hours); VPK/Enrichment 6 hours free model that combines VPK funding with either Title 1 or Exceptional Student Learning Support funding) and a 300 hour Summer VPK program. This Agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel.
