Dear Ms. Myrick:

Bryant Miller Olive P.A. (the "Firm") is currently representing The School Board of Broward County, Florida (the "Board") as Cadre Counsel for certain labor and employment law matters. The Firm also represents J.P. Morgan Securities, LLC (the "Underwriter") as underwriter's counsel in connection with the underwriting of the above-captioned certificates of participation (the "COPs"). The representation of the Underwriter in the issuance of the COPs is limited to reviewing and commenting on the financing documents, including, but not limited to, the certificate purchase contract and the preliminary offering statement, and assisting with due diligence. The Firm's representation of the Underwriter in the issuance of the COPs is completely unrelated to the Firm's representation of the Board in any labor and employment matters.

Although we believe that the Underwriter and the Board's interests are generally aligned in the issuance of the COPs, such circumstances constitute a "technical" conflict of interest that requires consent from both clients. We are asking that the Board consent to the Firm's representation of the Underwriter in the COPs transaction. We reasonably believe that we will be able to represent the Board competently and diligently in the labor and employment matters without regard to our representation of the Underwriter in the unrelated COPs transaction.
