**THIS FIRST AMENDMENT TO AGREEMENT** is made and entered into as of this  
14<sup>th</sup> day of April, 2020, by and between

**THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA**  
(hereinafter referred to as "Owner"),  
a body corporate and political subdivision of the State of Florida,  
whose principal place of business is  
600 Southeast Third Avenue, Fort Lauderdale, Florida 33301

and

**ANATOM CONSTRUCTION COMPANY**  
(hereinafter referred to as "Contractor"),  
having its principal place of business at  
490 Business Park Way  
Royal Palm Beach, FL 33411

**WHEREAS**, the Owner and Contractor entered into a Construction Agreement dated December 10, 2019 (hereafter "Agreement") for SMART Program Renovations at Stirling Elementary School (the "Project"); and

**WHEREAS**, through inadvertence and error, an incorrect list of drawing was incorporated into Article 2.02 of the Agreement; and

**WHEREAS**, Owner and Contractor acknowledge and agree to replace the incorrect list of drawings incorporated into Article 2.02 of the Agreement; and

**WHEREAS**, Owner and Contractor acknowledge and agree that the Agreement is in full force and effect as revised by this First Amendment.

**NOW THEREFORE**, in exchange for the mutual covenants and promises set forth herein and other good and valuable consideration, the parties agree as follows:

1. **Recitals.** The recitals contained herein are true and correct and are incorporated herein by reference.
2. **Amended Provision.** Replace Article 2.02 of the Agreement in its entirety with "Document 00015: List of Drawings" which is attached hereto as **Exhibit "A."**
3. **Other Provisions Remain in Force.** Except as expressly provided herein, all other portions of the Agreement remain in full force and effect.

4. **Order of Precedence among Agreement Documents.** In the event of conflict between the provisions of the Agreement and the provisions contained herein, the provisions of the following documents shall take precedence in this order:

- a) this First Amendment to Agreement; then
- b) the Agreement.

5. **Authority:** Each person signing this First Amendment on behalf of either party warrants that he or she has full legal power to execute this First Amendment on behalf of the party for whom he or she is signing it to bind and obligate such party with respect to all provisions contained in this First Amendment.

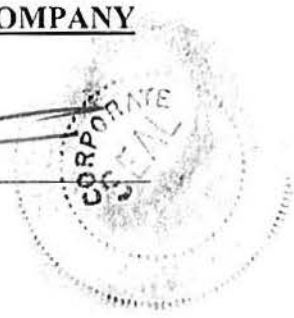

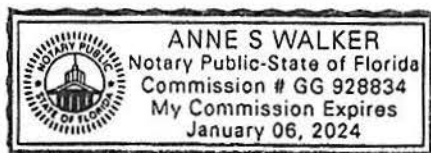
