Item 1. Amendment August 11, 2020 Special Meeting - Reopening Plan

Motion to Amend (Carried)

Motion was made by Mrs. Good, seconded by Mrs. Rupert and carried, to amend the Overview on page 3 and modifying it to include language pertaining to minimum considerations for a successful reopening.

Second Motion to Amend (Carried)

Motion was made by Mrs. Rich Levinson, seconded by Dr. Osgood and carried, to amend page A85 and add language to make it clear that #3 is the scenario to be used once schools reopen.

Third Motion to Amend (Carried)

Motion was made by Mrs. Rich Levinson, seconded by Mrs. Good and carried, to amend page A50, second bullet, by adding language to read, "Face coverings will be required to be worn over nose and mouth, per policy, whenever students/staff are moving...."

Fourth Motion to Amend (Carried)

Motion was made by Mrs. Rich Levinson, seconded by Mrs. Good and carried, to amend page A186, first bullet under Summary, by deleting the last two (2) sentences and add the following language after the third sentence to read, "Teachers should be flexible and take into account extenuating circumstances of individual students and may consider other evidence of attendance in these individual cases."

Fifth Motion to Amend (Carried)

Motion was made by Ms. Korn, seconded by Mrs. Bartleman and carried, to amend the second bullet at the bottom of page 3 to read, "...under prevailing circumstances ~~on or~~ ~~around October 1st, 2020~~ approximately every two (2) weeks." In addition, the language will be amended on page A40 in the blue section and in every place the date has been noted in the document.
