eLearning Phase 2 of Reopening Plans for 2020-21 School Year

Motion to Amend (Carried)

Motion was made by Mrs. Rupert, seconded by Mrs. Good and carried, to amend the timeline on page 9, Returning to campus: Proposed dates for a Phased PreK-12 return, as follows:

Thursday, October 8th - Teacher Planning Day

Friday, October 9th - Students in PreK-2 plus self-contained ESE classes and Centers will return for a full day

Monday, October 12th - Early Release for students in PreK-2 plus self-contained ESE classes and Centers

Tuesday, October 13th - Students in grades 3-6 and 9th grade will return for a full day

Wednesday, October 14th - Early Release for students in grades PreK-6 and 9th grade, plus self-contained ESE classes and Centers

Thursday, October 15th - All students, including grades 7-8, grades 10-12 and plus self-contained ESE classes and Centers, will return for a full day

Friday, October 16th - Early Release for all students as previously scheduled

Monday, October 19th - Teacher Planning as previously scheduled

Tuesday, October 20th - All students will return for the beginning of the next quarter

In addition, the 2020-2021 School Calendar will be amended to reflect that the October 8th Teacher Planning Day will replace the January 8, 2021 Teacher Planning Day in order to maintain the 180-day school calendar.
