

**THIRD AMENDMENT TO AGREEMENT BETWEEN BROWARD COUNTY AND
THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA
FOR FAMILY COUNSELING PROGRAM**

Agreement #: 19-CP-CSA-8267-02

This is a third amendment ("Third Amendment") to an agreement between Broward County, a political subdivision of the State of Florida ("County"), and The School Board of Broward County, Florida, a school board ("Provider"), for the Family Counseling Program (the "Agreement"). County and Provider are collectively referred to as the "Parties."

RECITALS

- A. The Parties entered into the Agreement on November 19, 2018.
- B. The Parties subsequently executed a First Amendment to the Agreement on September 24, 2019, to increase funding and the number of clients to be served during the Initial Term.
- C. The Parties then executed a Second Amendment to the Agreement on February 10, 2020, to exercise Option Period 1, increase funding, and determine the number of clients to be served during Option Period 1.
- D. The Parties now desire to amend the Agreement to further increase funding and the number of clients to be served during Option Period 1.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

- 1. The maximum funding amount payable by County under the Agreement will not exceed One Million Six Hundred Seventy Thousand Dollars (\$1,670,000) for Option Period 1.
- 2. Provider must provide program services under the Agreement to a minimum of three thousand seven hundred fifty-three (3,753) unduplicated Clients during Option Period 1.
- 3. This Third Amendment is effective June 1, 2020.
- 4. Except as expressly amended, all terms and conditions of the Agreement remain in full force and effect.
- 5. The Parties jointly prepared this Third Amendment.


