

**FIRST AMENDMENT TO AGREEMENT BETWEEN BROWARD COUNTY AND
THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA
FOR FAMILY COUNSELING PROGRAM**

Agreement Number: 19-CP-CSA-8267-02

This is the First Amendment ("First Amendment") to an agreement between Broward County, a political subdivision of the State of Florida ("County"), and The School Board of Broward County, Florida, a school board ("Provider") (collectively, the "Parties"), for Family Counseling Program (the "Agreement").

RECITALS

- A. The Parties entered into the original Agreement on November 19, 2018.
- B. The Parties desire to amend the Agreement to increase funding and the number of Clients to be served during the Initial Term.


Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:


- 1. For purposes of this First Amendment, the annual maximum amount payable by County will not exceed One Million Five Hundred Sixty-five Thousand Two Hundred Two Dollars (\$1,565,202) for the Initial Term.
- 2. For purposes of this First Amendment, Provider must provide services to a minimum of 3,521 unduplicated Clients during the Initial Term.
- 3. This First Amendment is effective June 1, 2019. Except as expressly amended, all terms and conditions of the Agreement remain in full force and effect.
- 4. The Parties jointly prepared this First Amendment.
- 5. This First Amendment may be executed in multiple originals and may be executed in counterparts, each of which will be deemed to be an original, but all of which, taken together, constitutes one and the same agreement.


