TITLE:	Interim 2007-2008 Salary Schedules						
REQUESTED ACTION:	Adopt the attached Interim 2007-2008 Salary Schedules which authorize the continuation of the salary schedules from the 2006-2007 school year until negotiations/meet & confer sessions are completed with the various unions and employee organizations. No general pay increases, including steps, will be granted until negotiations are concluded with the exception of the 2006-2007 BTU Teachers Salary Schedule which allows for a step increase that was previously Board-approved.						
SUMMARY EXPLANATION AND BACKGROUND:	The attached 2007-2008 Interim Salary Schedules (bargaining unit and non-bargaining unit employees), will remain in effect until permanent schedules are adopted by the Board. These schedules represent no change from the 2006-2007 salary schedules previously Board approved with the exception of the BTU Teachers Salary Schedule. The 2007-2008 BTU Teachers Salary Schedule reflects the step increase language that was previously Board-approved on September 6, 2006. The 2007-2008 schedule is included in this Interim 2007-2008 Salary Schedule Book.
