Termination of Agreement between The School Board of Broward County, Florida and the City of Pompano Beach

REQUESTED ACTION:

Approve the Termination of an Agreement between the School Board of Broward County, Florida and the City of Pompano Beach regarding off-site parking for the Dave Thomas East Center.

SUMMARY EXPLANATION AND BACKGROUND:

This Agreement gives the School Board the right to use thirty (30) parking spaces at Pompano Beach City Hall as overflow parking for the Dave Thomas East Center. The Center does not use the parking spaces. The City has entered into an Agreement with the County Commission to build a new regional library adjacent to City Hall. The site, however, cannot accommodate the required number of parking spaces. The City and County have requested the School Board to relinquish its right to the thirty (30) spaces at City Hall.

The School Board attorney has approved this agreement as to form and legal content.

BOARD does hereby release, cancel, forgive and forever discharge CITY and its directors, principals, employees, administrators, successors and assigns from all actions, claims, demands, damages, obligations, liabilities, controversies and executions, of any kind or nature whatsoever, whether known or unknown, whether suspected or not, which have arisen, or may have arisen, or shall arise by reason of the performance of services under the Agreement by CITY for BOARD and does specifically waive any claim or right to assert any cause of action or alleged case of action or claim or demand which has, through oversight or error intentionally or unintentionally or through a mutual mistake, been omitted from this Release.

The provisions of this Agreement must be read as a whole and are not severable and/or separately enforceable by either party hereto.
