Recommendation:

The Facilities and Construction Management Division intends to recommend that The School Board of Broward County, Florida, at the School Board meeting on **August 19th, 2008**, award a contract to the low bidder meeting bid specifications, **Enco, LLC**. The amount of the Contract shall be the sum of **\$714,000**, which includes the **Base Bid**.

All of the bidders, with the exception of Azulejo, Inc., are currently Pre-Qualified.

Any Bidder objecting to such action must comply with Florida Statutes, Chapter 120.57(3). In accordance with Board Policy 3320, VI (n), any person who files a formal written protest shall post with the School Board, at the time of filing the formal written protest, a bond, payable to The School Board of Broward County, Florida, an amount equal to one percent (1%) of the School Board's estimate of the total volume of the contract. The School Board shall provide the estimated contract to the protestant within 72 hours of the notice of protest, excluding Saturdays, Sundays, and other days during which the School Board administration is closed. Failure to file a protest, or post the bond or other security required by law within the time allowed for filing a bond, at the Facilities and Construction Management Division, 1700 SW 14th Court, Fort Lauderdale, Florida 33312, within the time described in s.120.57(3), Florida Statutes, shall constitute a waiver of proceedings under Chapter 120, Florida Statutes. Section 120.57(3), Florida Statutes, states that the formal written protest shall state with particularity the facts and law upon which the protest is based.
