Habitat for Humanity of Broward has become aware of the March 1, 2004 changes to Broward County's Land Development Code which stipulates that all new construction within Broward County will be subject to impact fees. Being a non-profit, these impact fees will be a significant financial hardship for our organization. As such, Habitat Broward is requesting the Broward County School Board waive the educational impact fees assessed to the above referenced properties.

As you know, Habitat Broward is a non-profit organization which serves only very-low and low income families, according to the Department of Housing and Urban Development income limit standards. Habitat Broward partners with these families in need to build safe, decent affordable housing.

Habitat Broward achieves its mission of eliminating poverty housing from our community through volunteer labor, tax deductible donations of money and materials, and governmental assistance in the form of impact fee waivers and other related fees.
