| SUMMARY EXPLANATION AND BACKGROUND: | The Professional Standards/Special Investigative Unit (PS/SIU) completed an investigation into allegations of failure to self-report arrest for drug possession. The allegation was thoroughly investigated and the results were presented to the Professional Standards Committee (PSC). PSC found probable cause and recommended termination. A pre-disciplinary meeting was held with the employee, a School Board cadre attorney and a representative from PS/SIU. The cadre attorney prepared the Petition for Formal Proceedings and notice was sent to the employee that a recommendation for termination would be presented to the School Board on January 25, 2011. | | | | | | |
