REQUESTED ACTION:	Receive the Petition for Formal Proceedings submitted by the Superintendent in reference to this teacher and that teacher be suspended immediately without pay pending final action on these charges.						
SUMMARY EXPLANATION AND BACKGROUND:	The Professional Standards/Special Investigative Unit (PS/SIU) completed an investigation into allegations of failure to self-report arrest for drug possession. The allegation was thoroughly investigated and the results were presented to the Professional Standards Committee (PSC). PSC found probable cause and recommended termination. A pre-disciplinary meeting was held with the employee, a School Board cadre attorney and a representative from PS/SIU. The cadre attorney prepared the Petition for Formal Proceedings and notice was sent to the employee that a recommendation for termination would be presented to the School Board on January 25, 2011.
