❖ First Amendment 4/4/00

- No change in scope.
- Increase the limit for Supplemental/Reimbursable Services from \$37,000 to \$73,500, due to the Fixed Limit of Construction Cost (FLCC) increase from \$1,500,000 to \$1,900,000.

❖ Second Amendment 4/17/01

- No change in scope.
- Increase the limit for Supplemental/Reimbursable Services from \$73,500 to \$207,000, due to the FLCC increase from \$1,900,000 to \$2,275,000 and needing further supplemental/reimbursable services.

Third Amendment 4/18/06

- Conversion of delivery method from Design/Bid/Build to Construction management at Risk.
- Change in scope: remodel existing student dining and teacher's lunchroom; replace air handlers in Buildings #1, 2, and 4; provide electrical service to power heat strips; direct digital HVAC controls; provide minor chiller plant improvements revise piping layout and pumps to improve capacity; replace marker and tack boards in designated classrooms; ADA replacement room signage for designated rooms; ADA hardware upgrades for designated doors; ADA remodeling for Restrooms 101C and 101D; ADA renovation to bleacher seating; addition to athletic equipment storage Building #9; provide handicap lift to the stage in the auditorium; testing/monitoring of existing indoor air quality to determine HVAC design criteria. Fees for revisions to the HVAC and electrical plans, if present indoor air quality is found to be inadequate, are not included. The exact extent of revisions, if any, will be determined by SBBC based upon testing and recommendations.
- Increase the limit for Supplemental Services from \$207,000 to \$209,500 and Basic Services Fees from \$131,000 to \$198,370.

- Rescind the Third Amendment dated 4/18/10: Conversion to Construction Management at Risk delivery method.
- Re-permitting of project to FBC-2007.
- Revise electrical distribution for this project as caused by other recent projects on campus.
- Reselect AHU's the original equipment selected has been discontinued.
- Redesign controls and heater for AHU-16A.
