WITNESSETH

WHEREAS, FDOT is currently constructing certain improvements as part of the Interstate 595 expansion project (the "Project"); and

WHEREAS, in conjunction with the Project, FDOT has obtained an order of taking for the property identified as Parcel #124 in that certain eminent domain case under CASE #10-24207 pending in the 17th Judicial Circuit in and for Broward County, Florida, which parcel was formerly a portion of the Fox Trail Elementary School, owned by the School Board, containing certain improvements consisting of a sidewalk and 2-fences (1 on the North Side of the sidewalk and 1 on the South side of the sidewalk) collectively (the "Existing Improvements"); and

WHEREAS, in conjunction with the afore-referenced taking of Parcel #124, FDOT intends to remove the Existing Improvements.

WHEREAS, in order to protect and secure the Fox Trail Elementary School site the School Board requested that FDOT reconstruct the Existing Improvements, including a 5' or greater sidewalk, a sodded and/or landscaped buffer (between the curb and gutter and the sidewalk) and 2-6' chain link fences (the "New Improvements"), in accordance with the plans depicted on the attached Exhibit "A"; and

WHEREAS, FDOT has agreed, at its expense, to construct the New Improvements, provided that the School Board convey additional property to FDOT, which property is identified as Parcel #130 on the attached Exhibit "B"; and

WHEREAS, the School Board is agreeable to conveying the property identified as Parcel #130, provided FDOT shall construct the New Improvements in accordance with the terms of this Agreement.

NOW THEREFORE, in consideration of the mutual covenants contained herein it is agreed as follows:

- 1. **Recitals.** The above recitals are true and correct and are incorporated herein by reference.
- Conveyance. Upon the Effective Date of this Agreement, the School Board shall convey by Special Warranty Deed, a copy of which is attached hereto as Exhibit "C", to FDOT, the property identified as Parcel 130. FDOT shall forthwith, at its expense, record the Special Warranty Deed in the Public Records of Broward county, Florida.
- 3. Construction. In conjunction with the removal by FDOT of the existing improvements, FDOT shall construct, at its expense, the New Improvements or temporary improvements as necessary prior to the New Improvements. Removal of the existing improvements and construction of the New Improvements shall be coordinated in such a manner as to secure the Fox Trail Elementary School property at all times.
- 4. Landscaping. FDOT shall, at its expense, continuously maintain the New Improvements and landscaping on Parcel 130.
- 5. **Completion.** The DOT shall cause the removal of the Existing Improvements and construction of the New Improvements no later than July 2014.
- 6. **Default.** In the event that FDOT shall default in its obligations to construct the afore-referenced improvements the School Board shall have the right to enforce this Agreement by Specific Performance, in which event the prevailing party shall be entitled to an award of attorney's fees and costs.
- 7. **Venue.** The venue for any action to enforce the terms of this Agreement shall be in Broward County, Florida.
- 8. **Effective Date.** The Effective Date shall be the date on which the last of the Parties executes the Agreement.


