School Board Policy 1341 was recently revised along with its associated fee schedule, and became			
effective upon approval by the School Board on January 25, 2011. Rule No. 7 of the Policy			
requires that the Fee Schedule shall be reviewed no less than annually "by the Lease Committee			
which will recommend any changes to the Superintendent for approval by the School Board."			
School Board Policy 1341 Committee which consists of staff from various District departments,			
the three area offices, and certain school based staff meet as needed to review all matters (which			
include the Fee Schedule) pertaining to the Policy, and as appropriate, recommend changes. In			
compliance with the provisions of the Policy, the Committee met on February 9, 2012 and			
recommended a revised Fee Schedule to the Superintendent.
