Reject bids received for the following reasons. Evaluation of bids ceased upon discovery that the item offered did not meet the specifications as described on the Bid Summary Sheet and Special Conditions of the bid.

Item 1A,B:

Reject bid from CEI Medical Supply. Special Condition 15, Catalogs/Price List(s) (Item1) states that Bidder(s) shall furnish, with the bid, or upon request, one copy of their current awarded manufacturers' catalog(s)/manufacturer's suggested retail price list(s) (MSRP) and/or distributor's catalog/price list which will indicate all items Bidder can furnish and the list prices to be used for each item. Failure of Bidder to furnish with the bid, or upon request, a manufacturer's/distributor's catalog/price list will result in disqualification of bid submitted. Bidder did not provide the catalog/price list with the bid, or upon request, therefore Bidder is non-compliant to Special Condition 15, and considered non-responsive.

Item 2:

Reject bid from <u>District Healthcare & Janitorial Supplies</u>. Special Condition 1, Introduction and Scope, states that **SBBC will purchase only ready-made, "off the shelf" (not customized) first aid kits that meet the specifications included in the bid.** After researching and evaluating the brand and model offered by Bidder on the Internet, it has been determined that the item offered is a customized, not ready-made first aid kit, therefore, Bidder is non-compliant to Special Condition 1, and considered non-responsive.

Reject bid from Wastetrans LLC, d/b/a Netcare Medical. Special Condition 19, Descriptive Literature and Samples (Item 2), states that Bidder is required to provide Complete Descriptive Literature on each component of the first aid kit being offered, and one each of the exact sample of the kit offered, with the bid or upon request. Such literature shall be in sufficient detail to indicate conformance with the specifications included in the bid. Bidder offered a first aid kit that did not include all the required components that were listed in the specifications of the bid.
