EXECUTIVE SUMMARY Alpha International Academy, Inc. Alpha International Academy

Alpha International Academy, Inc., desires to amend its charter agreement by changing the location of Alpha International Academy for school year 2012-2013 and subsequent years.

The charter school will be located at: 520 N.W. 5^{th} Street Hallandale Beach, Florida 33009.

FIRST AMENDMENT TO CHARTER AGREEMENT

WHEREAS, the parties entered into a Charter School Agreement (AGREEMENT) on April 17, 2012, which incorporates by reference the SCHOOL's Charter School Application wherein the SCHOOL was authorized to operate a charter K-5 known as "Alpha International Academy" in Broward County, Florida and

WHEREAS, Section 2.B.4 of the AGREEMENT permits the amendment of that agreement during its term through mutual agreement of the parties, provided such modifications are agreed to in writing and executed by both parties; and.

WHEREAS, the School desires to amend its AGREEMENT to relocate the SCHOOL to a new location.

- **NOW, THEREFORE**, in consideration of the premises and of the mutual covenants and terms herein set forth, the parties agree as follows:
- 1.01 <u>Recitals</u>: The foregoing recitals are true and correct and are incorporated within this Charter by reference.
- 1.02 <u>Amended Provisions.</u> The parties agree to amend the Agreement to provide as follows:

Section 6.A.1 <u>Facility Location</u>: Beginning with the 2012-2013 school year, the charter school shall be located at: 520 NW 5th Street, Hallandale Beach, Florida 33009.

 - (a) This First Amendment to the Charter Agreement;
 - (b) The Charter Agreement; and
 - (c) The Charter Application
- 1.04 Other Provisions, as Amended, Remain in Force: Except as expressly provided herein, all other portions of the agreement remain in full force and effect.
- 1.05 <u>Authority</u> Each person signing this First Amendment to the Agreement on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment to the Agreement.
