EXECUTIVE SUMMARY

Sunshine Elementary Charter School, Inc. Sunshine Elementary Charter School

Sunshine Elementary Charter School, Inc., desires to amend its charter agreement by changing the location of Sunshine Elementary Charter School for school year 2012-2013 and subsequent years.

The address of the charter school for the 2011-2012 school year was: 2210 Pierce Street Hollywood, Florida 33020.

The charter school will be located at: 502 N. 28th Avenue Hollywood, Florida 33020.

The original agreement with Sunshine Elementary Charter School, Inc., was approved at the June 21, 2011 Regular School Board Meeting, Item F-4. The term of the charter shall remain the same, covering five years commencing on July 1, 2011 and ending June 30, 2016.

The Mayor and the City Manager for the City of Hollywood have been notified of the change.

The governing board members of Sunshine Elementary Charter School, Inc., reside in Broward County.

FIRST AMENDMENT TO CHARTER AGREEMENT

SUNSHINE ELEMENTARY CHARTER SCHOOL, INC. Sunshine Elementary Charter School

a Florida not-for-profit organization [hereinafter referred to as "School"], and having its principal place of business located at 502 N. 28th Avenue Hollywood, Fl 33020

WHEREAS, the parties entered into a Charter School Agreement (AGREEMENT) on June 21, 2011, which incorporates by reference the SCHOOL's Charter School's Renewal Application wherein the SCHOOL was authorized to operate a K-5 charter known as "Sunshine Elementary Charter School" in Broward County, Florida and

WHEREAS, Section 2.B.3 of the AGREEMENT permits the amendment of that agreement during its term through mutual agreement of the parties, provided such modifications are agreed to in writing and executed by both parties; and.

WHEREAS, the School desires to amend its AGREEMENT to relocate the SCHOOL to a new location.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants and terms herein set forth, the parties agree as follows:

- 1.01 <u>Recitals</u>: The foregoing recitals are true and correct and are incorporated within this Charter by reference.
- 1.02 <u>Amended Provisions.</u> The parties agree to amend the Agreement to provide as follows:

Section 6.A.1 <u>Deadline to Secure Facility</u>: Beginning with the 2012-2013 school year, the charter school shall be located at: 502 N. 28th Avenue Hollywood, Fl 33020.

Section 6.C.1 School's Street Address: The charter school shall be located at: 502 N. 28th Avenue Hollywood, Fl 33020.

- 1.03 Order of Precedence Among Agreement Documents: In the event of a conflict between the provisions of the agreement and the provisions contained herein, the provisions of the following documents shall take precedence in this order:
 - (a) This First Amendment to the Charter Agreement;
 - (b) The Charter Agreement; and
 - (c) The Charter Application
- 1.04 Other Provisions, as Amended, Remain in Force: Except as expressly provided herein, all other portions of the agreement remain in full force and effect.
- **1.05** <u>Authority</u> Each person signing this First Amendment to the Agreement on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment to the Agreement.
