TITLE: Approval to Notify Kidz Choice Charter School, Inc., (Kidz Choice Charter School - 5409) of the Proposed One-Year Renewal of its Charter School Agreement											
REQUESTED ACTION: Authorize the Superintendent to notify Kidz Choice Charter School, Inc., (Kidz Choice Charter School - 5409) of the proposed one-year renewal of the Charter School Agreement and approve the Charter Renewal Application.											
SUMMARY EXPLANATION AND BACKGROUND: <p>Pursuant to Section 1002.33(8)(b), Florida Statutes, a school's Charter School Agreement may be renewed subject to a program review and provided that none of the statutory grounds for non-renewal have been documented. The Superintendent's Charter School Review Committee has reviewed and analyzed the Charter Renewal Application submitted by Kidz Choice Charter School, Inc., (Kidz Choice Charter School - 5409) and has recommended a one-year renewal of its Charter School Agreement.</p> <p>It is requested that The School Board of Broward County, Florida, authorize the Superintendent to send the letter (Exhibit 3), notifying Kidz Choice Charter School, Inc., (Kidz Choice Charter School - 5409) of the approval of the Charter Renewal Application and of the proposed one-year renewal of the Charter School Agreement.
