Reject entire proposal from <u>Signs of Excellence, LLC</u>. In accordance with Section 4.4.3 of the RFP, states multiple hourly rates shall result in disqualification of proposal. Proposer offered multiple or tier pricing.

Reject cost proposal from <u>Soliant Health, Inc</u>. for Section 4.4.3, #1. In accordance with Section 4.4.3 of the RFP, states multiple hourly rates shall result in disqualification of proposal. Since these items can be bid individually, Items 2, 3, and 4 are considered for award. Soliant shall not offer services for Item 1.

Reject proposal from <u>Nationwide Interpreter Resource, Inc</u>. Section 5.3 of the RFP allows for SBBC and the Proposer to enter into negotiations. Proposer conditioned the RFP with the following statement:

If a job is cancelled with less than 24 business hours and the interpreter cannot be reassigned to another school, NIR will bill SBBC in full for the total number of hours assigned for that day.

Proposer would not change the above statement to meet the one (1) hour "no-show" requirement as required in Section 4.4.3. Evaluation Committee decided that an "Impasse" was reached and could not come to a mutual decision. The award for this Proposer was based upon a successful negotiation; therefore, the proposal was rejected.
