- 1. "Licensor" or "Attachmate" means, as the context requires, the Licensor listed in the header above, for itself or on behalf of Attachmate Corporation or any other wholly owned subsidiary that provides licenses to the Software or maintenance to Licensee under the Agreement.
- 2. Quote Expiration: agrees to submit (i) a signed copy of the Quote no later than July 31, 2013 and (ii) an order for the Transaction no later than August 30, 2013. The offer contained in this Quote may be withdrawn by Licensor if Customer fails to meet the deadlines outlined in the previous sentence.
- 3. Taxes: Taxes will be added to Customer's invoice unless a current tax-exempt certificate is provided to Licensor at the time the order is placed.
- 4. Payment: Unless otherwise specified in writing by Licensor, all payments under this Agreement are due and payable net thirty (30) days from the date of invoice. Terms are subject to credit approval. License fees are invoiced upon receipt of the applicable purchase order. All past due amounts under this Agreement accrue interest at the lower rate of 12% per annum, or the highest amount allowed by law, from the due date until fully paid. In any action to collect past due amounts under this Agreement, Customer shall pay Licensor's reasonable attorneys' fees and costs of collection.
- 5. Audit: Licensor reserves the right to audit Licensee's compliance with the terms of this Agreement on an annual basis, or as otherwise specified in the applicable SLA.
- 6. **Export:** Attachmate software may not be shipped, transferred, or exported in any manner prohibited by US export laws, restrictions, or regulations of any jurisdiction.

7. **Removal of Certain Shortfall Copies:** Because Attachmate can no longer offer additional license rights to the products listed in Table Two below each an "Obsolete Product". The 737 unlicensed but installed copies of Obsolete Product identified in the license verification must be removed and destroyed. Customer's required purchase of licenses in the Transaction listed in Table One will provide Customer with licenses for the replacement product EXTRA! X-treme v. 9.2. Customer agrees to confirm de-installation of the Obsolete Products listed in Table Two no later than March 31, 2014.

- 8. **Data Sources:** A verification was conducted by Customer on September 7-13, 2012 of installations of Attachmate software products ("Inventory") on computing systems of Customer and Customer entities in the Customer's computing environment in Broward County ("Audited Entities"). For the purpose of reviewing the Inventory data, Attachmate and Customer agreed to consolidate the existing entitlement records associated with Customer including licenses acquired by Customer–identified predecessor entities and currently affiliated entities listed in Table Three in Florida (collectively, the "Included Entitlements"). For the avoidance of doubt, the Included Entitlements were purchased under the following names listed in Table Three. The comparison of the Inventory data to the Included Entitlements identified an over-deployment of the Attachmate software by the Audited Entities ("Over-Deployment").
- 9. **License Transfer:** In agreeing to the purchase transaction described in Table One above ("Transaction") subject to the terms of this Quote, Attachmate consents to the one-time transfer of the Included Entitlements to Customer licenses not already in Customer's name and Customer warrants to Attachmate that Customer desires such a transfer and has the authority to affect such transfers of the Included Entitlements. Upon completion of the Transaction, the Post Transaction Entitlement will be consolidated onto Volume Purchase Account ("VPA") # 107038 under the name The School Board of Broward County, Florida.
- 10. **Release:** Customer's full payment of all elements of the Transaction and adherence to the terms and conditions of this Quote will remedy the Over–Deployment. Relying on the completeness and accuracy of Customer's Inventory, Attachmate thereupon releases the Audited Entities and their affiliates and successors in interest from any and all claims Attachmate may have related to the Over–Deployment.
- 11. **Confidentiality:** The parties acknowledge that this Agreement is a public record pursuant to Section 119.07, Florida Statutes, and will be submitted for approval by the Licensee at a public meeting pursuant to Section 286.011. Florida Statutes.
