

FIRST AMENDMENT TO THE CHARTER SCHOOL

This First Amendment to the CHARTER AGREEMENT is made and entered into as of this _____ day of _____ 2013, by and between:

THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA,

a body corporate operating and existing under the laws of the State of Florida
[hereinafter referred to as "Sponsor"],
and having its principal place of business located at
600 Southeast Third Avenue, Fort Lauderdale, Florida 33301

and

N.E.W. GENERATION PREPARATORY HIGH SCHOOL OF PERFORMING ARTS, INC.

a Florida not-for-profit organization [hereinafter referred to as "School"],
and having its principal place of business located at
6854 NW 173rd Drive, Unit 208
Hialeah, Florida 33015

WHEREAS, the parties entered into a Charter School Agreement (AGREEMENT) on or about November 5, 2013, which incorporates by reference the SCHOOL's Charter School Application wherein the SCHOOL was authorized to operate a charter 9-12 known as "N.E.W. Generation Preparatory High School for Performing Arts" in Broward County, Florida and

WHEREAS, Section 2.B.4 of the AGREEMENT permits the amendment of that agreement during its term through mutual agreement of the parties, provided such modifications are agreed to in writing and executed by both parties; and,

WHEREAS, the School desires to amend its AGREEMENT to relocate the SCHOOL to a new location.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants and terms herein set forth, the parties agree as follows:

1.01 Recitals: The foregoing recitals are true and correct and are incorporated within this Charter by reference.

1.02 Amendments: The following portion of the Charter School Agreement shall be amended to provide as follows:

**N.E.W. Generation Preparatory High School of Performing Arts
First Amendment to Charter School Agreement**

ARTICLE 6: FACILITIES

Section 6.A.1: **Facility Location:** The facility to be used by the SCHOOL beginning with the 2013-14 for operations of the charter school shall be located at: 600 S.W. 3rd Street, Pompano Beach, Florida 33060.

1.03 Order of Precedence Among Agreement Documents: In the event of a conflict between the provisions of the agreement and the provisions contained herein, the provisions of the following documents shall take precedence in this order:

- (a) This First Amendment to the Charter Agreement;
- (b) The Charter Agreement; and
- (c) The Charter Application

1.04 Other Provisions, as Amended, Remain in Force: Except as expressly provided herein, all other portions of the agreement remain in full force and effect.

1.05 Authority Each person signing this First Amendment to the Agreement on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment to the Agreement.

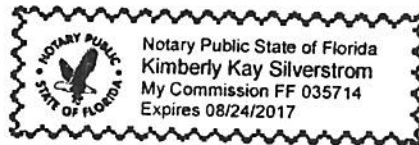


