Reject as not responsive the proposal received from Jacobs Project Management Co. for failure to comply with; Policy 1100B, Lobbyist Activities For Economic Gain, Rule 11, Prohibition of Lobbying; Policy 3320, Purchasing Policies, Part II, General Provisions, Paragraph HH, Cone of Silence; and the Request For Qualifications, General Requirements & Instructions to Bidders, page 1 Cone of Silence, and Article I, General Requirements, Paragraph I, Cone Of Silence.

Approve the final selection, and if successfully negotiated, award a contract to URS Corporation Southern as per Article III.G of the RFQ, based upon the scoring and recommendation of the Qualification Selection Evaluation Committee.

In accordance with Board Policy 3320, VI (n), any person who files a formal written protest shall post with the School Board, at the time of filing the formal written protest, a bond, payable to The School Board of Broward County, Florida, an amount equal to one percent (1%) of the School Board's estimate of the total volume of the contract. The School Board shall provide the estimated contract to the protestant within 72 hours of the notice of protest, excluding Saturdays, Sundays, and other days during which the School Board administration is closed. Failure to file a protest, or post the bond or other security required by law within the time allowed for filing a bond, at the Supply Management & Logistics Dept., 7720 West Oakland Park Blvd., Suite 323, Sunrise, FL 33351 within the time described in s.120.57(3), Florida Statutes, shall constitute a waiver of proceedings under Chapter 120, Florida Statutes. Section 120.57(3), Florida Statutes, states that the formal written protest shall state with particularity the facts and law upon which the protest is based.
