<b>SUMMARY EXPLANATION AND BACKGROUND:</b>	<p>The audited Comprehensive Annual Financial Report (CAFR) is prepared in accordance with Generally Accepted Accounting Principles. The CAFR will be submitted to both the Association of School Business Officials International (ASBO) and the Government Finance Officers Association (GFOA) for consideration of the Certificate of Excellence and the Certificate of Achievement for Excellence in Financial Reporting awards. In order to be awarded these respective Certificates, the District must publish an easily readable and efficiently organized report. The District has received the Certificate of Excellence for the preceding thirty years from ASBO and has received the Certificate of Achievement for Excellence for the preceding seventeen years from GFOA. The CAFR was reviewed and approved by the Audit Committee on November 14, 2013.
