TITLE: Approve the Termination of the Charter School Agreement Between N.E.W. Generation Preparatory High School of Performing Arts, Inc., (N.E.W. Generation Preparatory High School of Performing Arts - 5390), and The School Board of Broward County, Florida.		
REQUESTED ACTION: Approve the Termination of the Charter School Agreement Between N.E.W. Generation Preparatory High School of Performing Arts, Inc., (N.E.W. Generation Preparatory High School of Performing Arts - 5390), and The School Board of Broward County, Florida.		
SUMMARY EXPLANATION AND BACKGROUND: On May 21, 2013, N.E.W. Generation Preparatory High School of Performing Arts, Inc., (N.E.W. Generation Preparatory High School of Performing Arts - 5390), entered in to a Charter School Agreement with The School Board of Broward County, Florida, that became effective July 1, 2013, and covered a term of five years commencing on July 1, 2013, and ending June 30, 2018. N.E.W. Generation Preparatory High School of Performing Arts, Inc., (N.E.W. Generation Preparatory High School of Performing Arts - 5390), was allowed to open the school at a temporary facility for a period of sixty (60) days. The temporary certificate of occupancy has expired and N.E.W. Generation Preparatory High School of Performing Arts, Inc., (N.E.W. Generation Preparatory High School of Performing Arts - 5390), has failed to provide a valid certificate of occupancy. On November 5, 2013, The School Board of Broward County, Florida, authorized the Superintendent to notify Between N.E.W. Generation Preparatory High School of Performing Arts, Inc., (N.E.W. Generation Preparatory High School of Performing Arts - 5390), of our intent to terminate the Charter School Agreement. An Executive Summary is attached which provides additional grounds and details for the termination.
