On December 2, 2013, The School board of Broward County, Florida, authorized the Superintendent to notify N.E.W. Generation Preparatory High School of Performing Arts, Inc., (N.E.W. Generation Preparatory High School of Performing Arts – 5390), of its intent to terminate the Charter School Agreement. N.E.W. Generation Preparatory High School of Performing Arts, Inc., (N.E.W. Generation Preparatory High School of Performing Arts - 5390), has failed to request a hearing.

AREAS OF DEFICIENCY

Section 6.C.1: Temporary Facility: The School may only use a temporary facility when the facilities approved within this agreement are temporarily not suitable for student use under all applicable laws, ordinances, and codes of federal, state, and local governance. Approved use of a temporary facility for a period of more than sixty (60) calendar days will require the amendment of this Charter by the parties;

The School's failure to comply with the above noted statutory and contractual obligations constitutes a material breach of the charter agreement.

Organizational:

- The school has failed to secure a valid certificate of occupancy for the permanent facility specified in its charter agreement located at 2890 N.W. 62nd Street, Fort Lauderdale, Florida 33309.
- The school has failed to secure a valid certificate of occupancy for the temporary facility located at 600 S.W. 3rd Street, Pompano Beach, Florida 33060.

N.E.W. Generation Preparatory High School of Performing Arts, Inc., (N.E.W. Generation Preparatory High School of Performing Arts – 5390), was allowed to open the school at a temporary facility located at 600 S. W. 3rd Street, Pompano Beach, Florida 33060, for a period of sixty (60) days due to the permanent facility not being approved for occupancy at the opening of the 2013-2014 school year. The sixty day time frame has expired and N.E.W. Generation Preparatory High School of Performing Arts, Inc., (N.E.W. Generation Preparatory High School of Performing Arts – 5390), has not been able to secure a certificate of occupancy for its permanent or temporary facility. The attached Executive Summary provides in reasonable detail the grounds for the termination.

On December 2, 2013, The School Board of Broward County, Florida, authorized the Superintendent to notify N.E.W. Generation Preparatory High School of Performing Arts, Inc., (N.E.W. Generation Preparatory High School of Performing Arts – 5390), of our intent to terminate the Charter School Agreement.

The Governing Board of N.E.W. Generation Preparatory High School of Performing Arts, Inc., (N.E.W. Generation Preparatory High School of Performing Arts – 5390), failed to submit an appeal to the State, therefore The School Board of Broward County, Florida, is hereby notifying you of the termination of the Charter School Agreement.
