On June 25, 2013, The Magnolia School for the Arts and Technology, Inc., was approved to defer the opening of the school until the 2014-2015 school year. The Magnolia School for the Arts and Technology, Inc., will be the non-profit entity contracting with The School Board of Broward County, Florida. The Magnolia School for the Arts and Technology, Inc., will serve students in grades 6-8 and will open in August 2014.

THIS CHARTER SCHOOL AGREEMENT is entered into as of the 4th day of Maych, 20 14 by and between:

THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA,

a body corporate operating and existing under the laws of the State of Florida [hereinafter referred to as "Sponsor"], and having its principal place of business located at 600 Southeast Third Avenue, Fort Lauderdale, Florida 33301

and

The Magnolia School for the Arts and Technology, Inc.,

a Florida not-for-profit organization [hereinafter referred to as "School"], and having its principal place of business located at 116 W. Pennsylvania Ave, Bonifay, FL 32425

WHEREAS, the Sponsor has the authority pursuant to Section 1002.33, Florida Statutes, to grant to a not-for-profit organization a charter to operate a charter middle school, grades 6-8, within the school district; and

WHEREAS, the School is a Florida not-for-profit organization and desires to operate a charter school within the school district for the purposes set forth in Section 1002.33, Florida Statutes, and in the School's Charter School Application which is attached hereto as Appendix 1 and incorporated herein by reference.

WHEREAS, the School is approved by the Sponsor to provide educational services in accordance with the terms of a charter school agreement; and

WHEREAS, it is the intent of the parties that this Charter School Agreement [hereinafter referred to as "Charter"] shall serve as the charter for the operation of the SCHOOL.

NOW, THEREFORE, in consideration of the mutual covenants and terms herein set forth, the parties agree as follows:
