a Florida not-for-profit organization [hereinafter referred to as "School"], and having its principal place of business located at 2360 West Oakland Park Blvd., Oakland Park, FL 33311.

WHEREAS, the Sponsor has the authority pursuant to Section 1002.33, Florida Statutes, to grant to a not-for-profit organization a charter to operate a charter high school within the school district; and

WHEREAS, the School is a Florida not-for-profit organization and desires to operate a charter school within the school district for the purposes set forth in Section 1002.33, Florida Statutes, and in the School's Charter School Application which is attached hereto as Appendix 1 and incorporated herein by reference.
