Reject Sections 4.4.3.10, 4.4.3.11 and 4.4.3.12 from <u>Salud Services, Inc. d/b/a Endeavor Bus Lines</u>. Section 4.4.3 states, "Multiple pricing shall disqualify bid item". Salud Services/Endeavor offered three different price schedules for Sections 4.4.3.10, 4.4.3.11 and 4.4.3.12 and disqualifies their proposal for these sections.
