Bringing a firearm or weapon, as defined in chapter 790, to school, to any school function, or onto any school-sponsored transportation or possessing, displaying, using, selling or transmitting a firearm at school.</li> </ol> <p style="color: blue;"><u>Note: A student may not be subject to mandatory expulsion proceedings if it is determined that the student immediately* reported or delivered the firearm or weapon to a staff member.</u></p> <p style="color: blue;"><u>The term “immediately” means without delay as determined by the principal after considering the totality of the circumstances.</u></p>	Clarifying language

OFFENSES LEADING TO MANDATORY EXPULSION</b></p> <p style="color: blue;"><u>Note: A recommendation for the Behavior Intervention Program assignment applies when an elementary level student commits an offense, within this section, for which a secondary level student would receive a mandatory expulsion under this policy.
