SUMMARY EXPLANATION AND BACKGROUND:	<p>Revisions to Policy 5.8 (Code of Student Conduct) has been made to provide clarification and information for stakeholders in understanding and implementing the Policy. Policy changes have been vetted in accordance with the process outlined in Policy 1001: Rule Adoption and Rule Making.</p> <p>The revisions were discussed at the first Board Workshop on November 12, 2013; at the Public Rule Development on December 18, 2013, at the Second Board Workshop on February 25, 2014 and at the first reading at the Regular School Board Meeting on April 1, 2014.
