

<b>TITLE:</b>	<b>Petition For Formal Proceedings - CT</b>		
<b>REQUESTED ACTION:</b>	Receive the Petition for Formal proceedings submitted by the Superintendent in reference to this teacher and that teacher be suspended without pay for three (3) days, subject to the teacher's appeal rights.		
<b>SUMMARY EXPLANATION AND BACKGROUND:</b>	The teacher, CT, has violated the principals of Professional Conduct for the Education Profession in Florida. Due to the severity of the infractions, a three (3) day unpaid suspension is recommended. The cadre attorney prepared the Petition for Formal proceedings and notice was sent to the employee that a recommendation for a three (3) day suspension without pay would be presented to the School Board on May 20, 2014. The teacher has the right to request a hearing with the Division of Administrative Hearings (DOAH) within 21 calendar days of the School Board action to appeal this disciplinary action.
