The above referenced RFP was released on April 22, 2009 and opened on June 3, 2009. Only one proposal was received in response to the RFP. Clearwire Spectrum Holdings III, LLC was initially selected by the School Board for continued negotiations toward a spectrum lease in accordance with Section 5.4 of the RFP. Despite the best efforts of Clearwire, the School Board and our respective advisors, we are unable to arrive at a combination of financial considerations and other services that meet the needs and expectations of The School Board of Broward County, Florida. For these reasons, negotiations have reached an impasse and have ceased; therefore, the above referenced contract will be closed.
