REQUESTED ACTION:	Receive the Petition for Formal proceedings submitted by the Superintendent in reference to this teacher and that teacher be suspended without pay for five (5) day subject to the teacher's appeal rights.										
SUMMARY EXPLANATION AND BACKGROUND:	The teacher, NP, has shown a gross disregard in following appropriate testing procedures and protocols. Due to the severity of the infractions, a five (5) day unpaid suspension is recommended. The cadre attorney prepared the Petition for Formal proceedings and notice was sent to the employee that a recommendation for a five (5) day suspension without pay would be presented to the School Board on June 24, 2014. The teacher has the right to request a hearing with the Division of Administrative Hearings (DOAH) within 21 calendar days of the School Board action to appeal this disciplinary action.
