## **EXECUTIVE SUMMARY**

iSuccess Academies of Southwest Florida, Inc. d/b/a iGeneration Empowerment Academy of Davie - 5242

The original agreement with iSuccess Academies of Southwest Florida, Inc., d/b/a iGeneration Empowerment Academy of Davie – 5242, was approved at the June 11, 2013, Regular School Board Meeting, Item E-3.

iSuccess Academies of Southwest Florida, Inc., d/b/a iGeneration Empowerment Academy of Davie -5242, desires to amend its Charter School Agreement to co-locate its charter school location with Eagles Nest Charter School —5355 and Eagles Nest Middle Charter School —5356—International School of Health, Beauty and Technology, for the 2014-2015 school year and subsequent years.

The School will provide annual written notification of the co-location to all parents of enrolled students. Additionally, the School's co-location status will be posted on the School's state mandated website.

iGeneration Empowerment Academy of Davie – 5242, will be located at 3698 N.W. 15<sup>th</sup> Street, Fort Lauderdale, Florida 33311 5950 West Oakland Park Boulevard, Lauderhill, Florida 33313, for the 2014-2015 school year and subsequent years.

The term of the Charter shall remain the same, covering five years commencing on July 1, 2013, and ending on June 30, 2018.
