TITLE:	Petition For Formal Proceedings - DM
REQUESTED ACTION:	Receive the Petition for Formal proceedings submitted by the Superintendent in reference to this teacher and that teacher be suspended without pay for one (10) days, subject to the teacher's appeal rights.
SUMMARY EXPLANATION AND BACKGROUND:	The teacher, DM, has shown a gross disregard in following appropriate procedures and protocols while on an off-campus activity with students. Due to the severity of the infractions, a ten (10) day unpaid suspension is recommended. Our attorney prepared the Petition for Formal proceedings and notice was sent to the employee that a recommendation for a ten (10) day suspension without pay would be presented to the School Board on July 22, 2014. The teacher has the right to request a hearing with the Division of Administrative Hearings (DOAH) within 21 calendar days of the School Board action to appeal this disciplinary action.
