PHYSICAL REHABILITATION THERAPY EQUIPMENT AND SUPPLIES

It is recommended that the contract with Achievement Products, Inc., Attainment Company, Inc., Branches Medical, Community Products LLC d/b/a Rifton, Medical Plastics Laboratory, Inc., Micro Bio Medics, and Sammons Preston be renewed for an additional year from October 19, 2001 through October 18, 2002 in accordance with Special Condition 4 of the bid. It is also recommended that the contract with Flaghouse, Inc. not be renewed, due to the fact that the bidder did not want to renew their contract. This recommendation does not require any changes to the District budget. This recommendation will allow the schools, departments and centers to continue purchasing physical rehabilitation therapy equipment and supplies as required through October 18, 2002.


