REQUESTED ACTION:	Approve the revised School Board policy 6.3: Supply Fees – Expendable Supplies at this <u>first reading</u>.						
SUMMARY EXPLANATION AND BACKGROUND:	<p>The Supply Fees Expendable Supplies policy was last reviewed in July, 1974. In recent years parent concerns have escalated regarding required fees for participation in credit bearing classes or classes that receive grades. This policy was discussed at the School Board Retreats on September 23, 2003 and March 8, 2005. In cooperation with the Office of the School Board Attorney, the policy has been revised.</p>
